**Approving the selection of the tender for the Acquisition, Delivery,
Installation and Hardware and Software Maintenance of “Meluxina-
AI” AI-optimised supercomputer for the European High Performance
Computing Joint Undertaking**

THE GOVERNING BOARD OF THE EUROHPC JOINT UNDERTAKING,

Having regard to Council Regulation (EU) 2021/1173 of 13 July 2021 on establishing the European High Performance Computing Joint Undertaking and repealing Regulation (EU) 2018/1488, as last amended by Council Regulation (EU) 2026/150 of 16 January 2026 on amending Regulation (EU) 2021/1173 on establishing the European High Performance Computing Joint Undertaking (hereinafter, “the JU Regulation”), in particular Article 12a thereof,

Having regard to the Statutes of the European High Performance Computing Joint Undertaking annexed to the Regulation (thereinafter “Statutes”) and in particular to Articles 1(i), 6(5) and 7(4)(g) thereof,

Having regard to EuroHPC Joint Undertaking Financial Rules, approved by Governing Board Decision 3/2020, of 20 February 2020¹ and, in particular to Article 43 thereof,

Having regard to the Governing Board Decision No 57/2024 of 7 October 2024 amending the Joint Undertaking’s Work Programme and Budget for the year 2024 (Work Programme and Budget Amendment No 5),

Having regard to the Governing Board Decision No 51/2024 of 10 September 2024 approving the launch of a call for expression of interest for the selection of Hosting Entities for the acquisition of an AI-optimised supercomputer or the upgrade of an existing EuroHPC supercomputer with AI capabilities, an advanced Experimental AI-optimised Supercomputing Platform (optional), and the establishment of an AI Factory

(EUROHPC-2024-CEI-AI-02, further amended by the Governing Board Decision No 59/2024 of 14 October 2024 (Amendment No 1)),

Having regard to the Governing Board Decision No 71/2024 of 9 December 2024 approving the selection of Hosting Entities for the acquisition of an AI-optimised supercomputer or the upgrade of an existing EuroHPC supercomputer with AI capabilities, an advanced Experimental AI-optimised Supercomputing Platform (optional), and the establishment of an AI Factory,

Having regard to Governing Board Decision No 04/2026 of 11 February 2026, approving the launch of the call for tenders for the acquisition, delivery, installation and hardware and software maintenance of “Meluxina-AI” AI-optimised Supercomputer,

WHEREAS

- (1) The Joint Undertaking shall acquire AI-optimised supercomputers and shall own them,
- (2) By Decision No 71/2024 of 9 December 2024, the Governing Board selected LuxProvide SA (“LuxProvide”) as Hosting Entity for the EuroHPC AI-Optimised Supercomputer (“Meluxina-AI”),
- (3) By Decision No 04/2025 of 11 February 2026, the Governing Board approved the launch of the call for tenders for the acquisition, delivery, installation and hardware and software maintenance of “Meluxina-AI” AI-optimised Supercomputer,
- (4) The evaluation procedure followed the applicable public procurement rules for the open procedures in the terms provided in the EU Financial Regulation. The Evaluation Committee was appointed by the Responsible Authorising Officer of the EuroHPC Joint Undertaking. Three external experts nominated by the EuroHPC Joint Undertaking assisted the Evaluation Committee with a detailed analysis against the award criteria,
- (5) Three economic operators submitted their applications, two of which were deemed eligible and administratively compliant. The admissible applications were evaluated by the Evaluation Committee (award criteria) and persons involved in the evaluation (exclusion criteria and selection criteria). The Evaluation Committee, taking into account external experts’ individual evaluation reports, concluded that one of the tenders passed all mandatory technical requirements as described in the technical specifications part of the call for tenders. The Evaluation Committee recommended to the Executive Director to award the contract to the admissible tender that passed all mandatory requirements. More details on the evaluation procedure are provided in the Evaluation Report,
- (6) The Executive Director has submitted the Evaluation Report to the Governing Board,

(7) The Governing Board took note of the outcome of the evaluation, which included the Evaluation Report with annexes. Consequently, the Governing Board

HAS ADOPTED THIS DECISION:

Article 1

The Governing Board approves the selection of the tender for the acquisition, delivery, installation and hardware and software maintenance of “Meluxina-AI” AI-optimised Supercomputer following the open procedure and in accordance with the Work Programme and Budget of the EuroHPC Joint Undertaking for the year 2024, and within the agreed available budget for the acquisition of the respective AI-optimised Supercomputer.

Article 2

The Executive Director shall inform the tenderer of the results of the evaluation and shall communicate simultaneously the relevant criteria scoring and analysis.

Article 3

This Decision shall enter into force on the date of its adoption.
