In case the application is submitted by several different legal entities from the same Participating State, this criterion (c) applies to all entities.</i></p> <p>The computing centres interested in applying for the call may be public sector entities, and not all public sector entities will be constituted as registered legal entities, for example, they could be statutory bodies. The computing centres would however be incorporated and have legal personality, so would align with criterion (b).</p>	<p>The requirement of a legal personality refers to the capacity of an entity to have legal rights and obligations, enabling it to act in its own name, such as entering into contracts, owning property, and being subject to legal proceedings. It shall be signed by the leader of Antenna consortium on behalf of such consortium and the Hosting Entity of an existing AI Factory on behalf of the AI Factory Hosting Consortium. In case of no hosting consortia, the Letter shall be signed by the sole applicants.

Then in the fourth bullet, the participation requirement is for the applicant to be a legal person, and that they must be able to demonstrate their existence as a legal person.</p> <p>So, I have two questions:</p> <p>1. How does EuroHPC distinguish between a legal entity and a legal person?</p> <p>2. What kind of evidence is required to be recognised as a legal person?</p>	<p>1. The notion of legal entity has a broader meaning than the legal person (including Public law bodies, Private law bodies, Private companies and Natural persons). Please also note that in accordance with the call conditions, only legal persons are eligible to apply (cf. Point (d) on p. 4 of the Call (51a1ed16-3e23-4fa6-aff5-05f68d91bf32_en).</p> <p>2.
